# Update on Client Identification Data ("CID") and Personal Information Collection Statement ("Statement") Concerning Hong Kong Investor Identification Regime ("HKIDR") and Over-The-Counter Securities Transactions Reporting Regime ("OTCR")

The Securities and Futures Commission ("SFC") issued the Consultation Conclusions Paper on proposals to implement an HKIDR and introduce an OTCR for shares listed on the Stock Exchange of Hong Kong ("SEHK") on 10 August 2021.


